PASSPORT providers must provide documentation that their vehicle drivers have completed a Passenger Assistance course meeting the minimum criteria as specified in Appendix c of ORC 5101:3-31-009 rule and approved by the PASSPORT Administrative Office (PAA). This DRIVE course meets the required ODA criteria. Some aspects of "Sensitivity to Aging" are covered in the DRIVE training, but not in the detail that the "Sensitivity to Aging" training provides.

The fee for each participant is \$50.
