Our exposure to the "situational ethics" of some creates the impression that ethics can be used conveniently rather than consistently. A second problem is that employers think that a written Code of Ethics will foster ethical behavior. This workshop is designed to dispel those myths, and will focus on how to use the NASW Code of Ethics as a basis for your agency's ethical standards, and how to make your agency's Code of Ethics a living document that is integrated into the personal and professional lives of those who embrace it.
