Suicide Prevention

Suicide is an increasing social problem in the United States. Many people get depressed at one point or another throughout life. Whether it is caused by death of a close friend or family member, environmental stress or mental illness, feelings of depression can become difficult for many people. Unfortunately, some people get so depressed as a result of their mental illness or life circumstances, that they consider suicide as an option to escape from their emotional pain. Most people who consider suicide don't really want to die, they just don't know how to cope with or eliminate the pain they are going through. Gaining a knowledge and understanding of suicide as well as prevention strategies is essential for anyone working with people who are potentially at risk. This training will provide participants with suicide prevention tools to identify, assess and assist.

The Presenters

Deanna Stump is the Suicide Prevention Coordinator at the Huntington Department of Veterans Affairs Medical Center (VAMC). She has been in suicide prevention at the VAMC for over eight years. She is licensed as an Independent Social Worker in the state of Ohio and is a MSW graduate of West Virginia University. She currently serves on the West Virginia Board of Suicide Prevention. In her spare time, she enjoys spending time with her family and traveling.

Belen Bushman is a Board Certified Advance Mental Health Nurse Practitioner in the Mental Health Clinic at the Huntington VAMC.
