## "Substance Abuse in the Elderly" Training Opportunity Provided Through AAA7

A continuing education training will soon be available in Piketon, sponsored by the Area Agency on Aging District 7 (AAA7). "Substance Abuse in the Elderly: The Hidden Epidemic" will be held on Wednesday, March 11<sup>th</sup> from 8:30 am until 12:30 pm at the Piketon Comfort Inn. Cost for the program is \$50 per attendee. Pre-registration is required. The deadline to register is Wednesday, March 4<sup>th</sup>.

Three (3) continuing education units (CEU) are available and meet social work requirements. The program is approved for the CEUs by the State of Ohio Counselor, Social Worker, and Marriage and Family Therapist Board. The Ohio Board of Nursing accepts events approved for counselors and social workers for continuing education contact hours. The program is also approved for three (3) continuing education units by the Board of Executives of Long-Term Services and Supports (BELTSS – formerly BENHA), as well as three (hours) of CEUs from the Ohio Department of Developmental Disabilities.

The program will aim to help attendees define chemical dependency, understand the difficulty in diagnosing alcoholism, gain new tools in identifying drug problems, and learn what best practices are. The featured speaker will be Charles Gorman, M.Ed., LPCC-S, LICIC-CS, who is an Associate Professor at Southern State Community College and Executive Director of FRS Counseling in Highland County.
