Free Healthy Living Workshop Available Soon
in Jackson to the Community

Live in Jackson County or surrounding communities? Do you or someone you know have long-term health challenges such as asthma, arthritis, heart disease, diabetes, and other life-long health conditions? Would you like to gain confidence and new skills to manage your chronic conditions and feel healthier?

“Healthy U” is a program made possible by a joint effort of the Ohio Department of Aging and the Area Agency on Aging District 7 (AAA7). In the workshop, that will soon be offered in Jackson County, the AAA7 is partnering with Holzer Assisted Living to offer this special evidence-based healthy aging program to local residents.

Participants in the Healthy U program will gain needed support in addition to a number of other benefits including:

- Learning practical ways to deal with pain, fatigue and depression
- Discovering ways to be more physically active
- Learning how to eat healthier
- Learning better ways to talk with your physician and family about your health
- Setting personal goals
- Finding ways to relax and deal with stress

The free six-week workshop will be offered at Holzer Assisted Living, located at 101 Markham Drive in Jackson. Sessions over the six-week period will be held on Wednesdays July 27th through August 31st. Each session will be held from 9:00 am until 11:30 am. Those participating should attend all six sessions. For those who register, anyone who attends at least four classes will be entered into a drawing for a Wal-Mart gift card.

Healthy U is open to anyone age 60 or older or enrollees with OPERS non-Medicare Medical Mutual. Participants in Healthy U can represent individuals with any of the conditions mentioned previously, be a caregiver of someone with these conditions, or be someone who simply wants to learn more about healthy living.
