## **It's Farmers' Market Time for Ross County Seniors!**

What could be better than fresh fruits and vegetables straight from the garden! Eligible seniors will have the opportunity to apply for coupons to purchase fresh fruits and vegetables at the Ross County Farmers' Market from area farmers who participate in the Senior Farmers' Market Nutrition Program.

The Senior Farmers' Market Nutrition Program is a partnership through the United States Department of Agriculture, the Ohio Department of Aging, the Area Agency on Aging District 7, Inc. (AAA7), and Ross County Committee for Elderly. Ross County residents who are age 60 or older and meet income guidelines can receive \$50 worth of coupons that can be used to purchase fresh produce and herbs from participating farmers at the Market. Examples of produce that can be purchased include but are not limited to: apples, berries, cherries, grapes, pumpkins, beans, cabbage, carrots, corn, potatoes, tomatoes, rhubarb and herbs, as well as honey.

This unique offer was first available to seniors in 2009 at the Ross County Farmers' Market and since that time has proved very successful. Fortunately, this special benefit will once again be offered to qualifying seniors who are registered for the program.

Applications for the program will be accepted at the Ross County Senior Citizens Center, located at 1824 Western Avenue in Chillicothe, on Thursday, April 26<sup>th</sup> beginning at 8:30 am (doors will open at 7:00 am). Enrollment in the program is on a first-come, first-serve basis. As a limited number of coupons are available, registration will be closed once all coupons have been distributed. The AAA7 will maintain all applications of those who register in the case additional funding should come available. Individuals wishing to enroll in the program **must be age 60 or older** at the time of the application (ID will be required), **must reside** in Ross County, and must meet the following **household** income guidelines - \$22,459 for a one-person household; \$30,451 for a two-person household; and \$38,443 for a three-person household. Spouses age 60 and older are also eligible for \$50 each (per household income guidelines). Additional information is available for households with four or more occupants.

“Providing seniors with ways to make healthy foods more accessible is our goal,” says Nina R. Keller, Assistant Director for the AAA7. “Utilizing the success of the Ross County Farmers’ Market and its wide variety of fresh and local produce makes it a true win-win situation for all – farmers and seniors.”

The Senior Farmers’ Market Nutrition project has been funded, at least in part, with federal funds from the US Department of Agriculture and the support of the Ohio Department of Aging and the Area Agency on Aging District 7, Inc., an equal opportunity provider.
