Participants age 55 or older were eligible to participate in the Show and were invited to a special reception to close out the event where ribbons were presented to winners of the many media categories and sub categories. Examples of art categories that were entered in the Contest included acrylic, oil, pencil, photography, and fabric. Participants in the variety of categories represented the counties served by the AAA7 which include Adams, Brown, Gallia, Highland, Jackson, Lawrence, Pike, Ross, Scioto and Vinton, as well as counties outside the tencounty district.
