### CareSource Partners with Southeast Ohio Area Agencies on Aging

#### **Home Care Waiver Program Helps Residents with Disabilities**

DAYTON - CareSource, a nonprofit Ohio-based health plan, is managing the Ohio Home Care Waiver program in Southeast Ohio. Beginning in January 2014, the Ohio Department of Medicaid contracted with CareSource to provide case management services for the Marietta region of the Ohio Home Care and Transitions Carve-Out Waivers.

The Ohio Home Care Waiver program provides cost-effective home and community-based services and supports for individuals who meet a nursing facility level of care, enabling them to remain in a community setting.

Services include: personal care services, out-of-home respite, nursing services, short-term relief, emergency response, supplemental transportation systems, adaptive/assistive devices, home-delivered meals, home modifications, adult day health services, and vehicle modifications.

To provide the most effective coordination for these services, CareSource partnered with the local Area Agencies on Aging (AAA) in Southeast Ohio (Districts 7, 8 and 9). The Southeast Ohio AAAs have extensive experience in coordinating waiver and community-based care and services, and have partnered with CareSource to ensure the highest quality of care is provided. Individual case managers from the local Area Agencies on Aging are assigned to coordinate services for individuals on the waiver within their service area.

“We welcome this opportunity to expand our mission to serve new and underserved populations in Ohio, and make a difference in the lives of people who need it most by improving their health care,” Anthony Evans, Vice President for Integrated Health Services at CareSource, said.

“After 42 years of continued existence, our Rio Grande Area Agency on

## Medicare Prescription Drug Plan Discount - Helping Eligible Individuals Save Money!

Assisting eligible individuals with Medicare prescription benefits is a service the Area Agency on Aging District 7 (AAA7) provides through the Medicare Improvements for Patients and Providers Act (MIPPA) grant from the Ohio Department of Aging. This project provides outreach to and enrollment assistance for individuals who may be eligible for the Low-Income Subsidy and/or Medicare Savings Program, as well as other Medicare premium assistance programs.



Low Income Subsidy (LIS) or “Extra Help” is a discount plan that can: lower your prescription co-pays; cover all or part of your Medicare Part D monthly premiums; or eliminate the “doughnut hole” of coverage for your medications. Part D is Medicare’s prescription drug coverage and is available to anyone eligible for Medicare Part A or Part B. Those with Medicare may enroll in Part D coverage through either a stand-alone plan or a Medicare Advantage plan. To be eligible for “Extra Help,” income guidelines and qualifications must be met, and the AAA7 can help determine whether you might be able to benefit from this program, and if so, assist you with the application process.

Each year, our Agency conducts outreach to our communities in order to better identify who might be eligible for the “Extra Help” program as there are a large amount of individuals who are eligible, but currently not receiving the benefit. Just last year, in 2013, 87 people, who called our Agency to inquire about the program, learned they were eligible and all combined were able to save a total of \$221,877.00, for an average savings of \$2,550.00 per person. All of the individuals we were able to reach out to throughout our communities during the year were also assisted in additional ways, including Medicare Part D sign-ups, help with finding a Medicare supplemental insurance, help with paying Part B premiums, providing other services made available through our Agency, and references to additional community organizations that may be able to help.

***Thanks to additional efforts to share the word about this wonderful program, in just the first five months of 2014, 71 individuals have called the AAA7 to inquire about the discount plan, with a savings so far this year of \$223,0700.00 - that’s more than our total for the entire twelve months of 2013!***

## **START TALKING!: Building a Drug Free Future**

Drug abuse is a public health epidemic across the nation and Ohio is not immune. In 2011, drug overdoses were the leading cause of accidental deaths in our state, with one Ohioan dying from a drug overdose every five hours. Under Governor John R. Kasich's leadership, Ohio has made attacking the drug problem a priority. Efforts are underway to broaden public and professional education, particularly regarding the prescribing and abuse of opioids; law enforcement has ramped up efforts on our highways and in our communities; and treatment options and recovery supports have been expanded to help those struggling with addiction regain control of their lives. **Start Talking!** is an effort championed by Gov. Kasich and First Lady Karen W. Kasich aimed at preventing drug abuse among Ohio's most vulnerable citizens – our children. Research shows that when children talk about substance abuse with parents, grandparents and other adults, they are up to 50 percent less likely to use. This initiative encourages Ohioans to embrace prevention-focused programs aimed at raising awareness and encouraging conversation, all in an effort to stop drug abuse before it starts. Ohio drug overdose deaths increased **440%** between 1999 and 2011, with prescription drugs driving that rise.

## Elder Abuse Awareness

A Department of Justice study estimated in 2009 that about one in nine adults age 60 and older suffers abuse each year. For every one case reported to authorities, it is believed that five more go unreported. A study reported in the Journal of the American Medical Association, also in 2009, found victims of elder abuse have a 300 percent higher risk of death than individuals not subject to abuse. Abuse can take many forms including physical, verbal, neglect, and financial exploitation.

World Elder Abuse Awareness Day is observed each year on June 15th. The Area Agency on Aging District 7, which covers 10 counties in Ohio, including Adams, Brown, Gallia, Highland, Jackson, Lawrence, Pike, Ross, Scioto and Vinton, encourages the community to be aware and educated about elder abuse. If you or someone you know is the victim of abuse, it is important to report it to the appropriate authorities.

According to the National Center on Elder Abuse, elder abuse is a term referring to any knowing, intentional, or negligent act by a caregiver or any other person that causes harm or a serious risk of harm to a vulnerable adult. The specificity of laws varies from state to state, but broadly defined, abuse may be:

- Physical Abuse - Inflicting, or threatening to inflict, physical pain or injury on a vulnerable elder, or depriving them of a basic need.
- Emotional Abuse - Inflicting mental pain, anguish, or distress on an elder person through verbal or nonverbal acts.
- Sexual Abuse - Non-consensual sexual contact of any kind.
- Exploitation - Illegal taking, misuse, or concealment of funds, property, or assets of a vulnerable elder.
- Neglect - Refusal or failure by those responsible to provide food, shelter, health care, or protection for a vulnerable elder.
- Abandonment - The desertion of a vulnerable elder by anyone who has assumed the responsibility for care or custody of that person.

Be aware of the risk factors and warning signs associated with elder abuse. Warning signs could include physical marks or physical mistreatment, behavioral changes, and sudden changes in financial situations. If you or someone you know has been the victim of abuse, exploitation or neglect, it is important to report the suspected abuse immediately. Call your doctor or confide in a family member or friend you trust, or call your local Adult Protective Services agency to report elder abuse occurring in the community. To report abuse in long-term care facilities, call the AAA7 Ombudsman Program at 1-800-582-7277. If someone you know is in immediate, life-threatening danger, call your local police department or sheriff's office, or 9-1-1 immediately.
